**NOTICE TO ALL U.S. GOVERNMENT ATTORNEYS
WHO ARE MEMBERS OF THE BAR OF
THE DISTRICT OF MINNESOTA
*** REQUIRED ATTORNEY RE-REGISTRATION *****

The U.S. District Court for the District of Minnesota requires members of its Bar to re-register every three years in order to maintain an accurate roll of admitted attorneys. The last re-registration was held in 2009 for H-M attorneys. The Clerk of Court is directed to give public notice to all admitted members of the Bar of this Court informing them that they must update their attorney records according to the following schedule:

Last Name Beginning with the Letters:

N-Z: February 10 - March 12, 2010

A-G: February - March 2011

H-M: February - March 2012

Therefore, attorneys with last names beginning with the letters **N-Z ONLY** must update their records with the Court on or before **March 12, 2010**. As an attorney for the U.S. Government, you are exempt from paying the required \$40.00 fee. Additionally, attorneys admitted to the Bar of this Court in either 2008 or 2009 do not need to re-register at this time.

To update your record, please log into your ECF account at <https://ecf.mnd.uscourts.gov>, click on UTILITIES, then click MAINTAIN YOUR ACCOUNT. After updating your information or confirming that it is accurate, please complete the [Government Attorney Re-Registration Affidavit](#) in portable document format (PDF) and save it to your computer. Then click on ATTORNEY RE-REGISTRATION under UTILITIES. ECF will direct you to enter case number 10-mc-100 for attorney re-registration and guide you through the online re-registration process.

Attorneys are encouraged to complete the re-registration process online through ECF as outlined above. Attorneys who elect not to complete the re-registration process online should mail, deliver or fax their re-registration affidavits to the Clerk of Court.

Separate notices will follow in 2011 and 2012 for those in subsequent alphabet groups. The Clerk of Court will not accept re-registration affidavits from attorneys outside the N-Z group at this time. Please adhere to the schedule above. Counsel who fail to re-register will be considered "inactive," their ECF accounts will be suspended, and they will be unable to obtain certificates of good standing.
