The Judicial Panel on Multidistrict Litigation has transferred actions in the above-captioned matter to this Court for coordinated and consolidated pretrial proceedings pursuant to 28 U.S.C. § 1407 as part of nationwide concussion injury litigation involving the National Hockey League. (Transfer Order [Doc. No. 1].) On January 8, 2015, the parties appeared before this Court for a status conference. This Order memorializes the matters discussed at the January status conference.

I. Medical Records Disclosure

The parties disagree about the proposed scope of Defendant's inquiry concerning Plaintiffs' medical records. The parties have agreed upon a briefing schedule, which is acceptable to the Court, and this matter will be heard at the February 5, 2015 status conference.

II. Designation of Deposition Exhibits

The parties' disagreement concerning the pre-designation of depositions exhibits remains under advisement with the Court and the resolution of this issue will be forthcoming.

III. Class Member Administrative Participation in Litigation

The parties continue to meet and confer regarding Plaintiff's proposed "Notice of Interest" administrative filing. The parties will address this issue at the February 5, 2015 status conference.

IV. Next Status Conference

The next status conference will be held on **February 5, 2015 at 2:00 p.m.**
