**ORDER AUTHORIZING SALE OF AND
TRANSFER OF TITLE TO ASSETS OF THE RECEIVERSHIP**

On the basis of the Motion of the Receiver, R. J. Zayed, for an order allowing the Receiver to sell and transfer title to specific assets of the Receivership (Docket No.: 174), the Court having been advised in the premises and having considered the materials before it enters the following:

IT IS HEREBY ORDERED THAT:

Pursuant to the Court's prior Orders seizing assets of and appointing a Receiver for the estates of the Defendants and Relief-Defendants, the Receiver has exclusive custody, control, and possession of the following assets:

- 2) 1985 Pontiac Fiero (VIN: 1G2PM37R8FP243441) registered in the name of Trevor Gilson Cook;
- 3) 2000 Jaguar STP (VIN: SAJDA01D4YGL08146) registered in the name of Trevor Gilson Cook;
- 4) 1989 Mercedes (VIN: WDBCA35E4KA493127) registered in the name of Trevor Gilson Cook;
- 5) 2004 Audi RS6 (VIN: WUAZZZ4N84B900987) registered in the name of Trevor Gilson Cook;
- 6) 1998 BMW Z3 (VIN: 4USCJ3336WLG20096) registered in the name of Market Shot LLC; and
- 7) 2000 Lexus (VIN: JT8BF28G0Y5102111) registered in the name of Market Shot LLC

IT IS FURTHER ORDERED THAT:

Title to all the assets identified herein is properly vested in the Receiver.

IT IS FURTHER ORDERED THAT:

As Receiver for the estate of Trevor Cook, Market Shot, LLC, and all other named Defendants and Relief-Defendants, the Receiver has full power and authority to sell the assets identified herein.

IT IS FURTHER ORDERED THAT:

As Receiver for the estate of Trevor Cook, Market Shot, LLC, and all other named Defendants and Relief-Defendants, the Receiver has full power and authority to require the Minnesota Department of Public Safety, Driver and Vehicle Services to issue duplicate titles as directed by the Receiver and to transfer title in the assets identified herein.
