ORDER

This matter is before the Court pursuant to the Receiver's motion to approve settlements with Core Alternative Investments, LLC ("Core") and its shareholders Robert Brooke, Steven Schwab, Paul Deming, and Thomas Newberry and to grant ancillary relief (Docket Nos. 570 and 607). The Court being fully advised in the premises hereby **ORDERS** as follows:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Receiver's Motion to Approve Settlements with Core and with Brooke, Schwab, Deming, and Newberry and to Grant Ancillary Relief is **GRANTED**. Notwithstanding the provisions of the Court's Orders imposing an asset freeze and appointing the Receiver, ADM Investor Services, Inc. ("ADM") shall wire transfer to an account controlled by the Receiver the full balance held by ADM in a commodity futures trading account for Oxford Global Managed Futures Fund, LP ("Fund") no later than 7 business days after service of this Order. Service of this Order may be accomplished by any means which provides ADM actual notice of the terms of this Order, including fax, email, and delivery by overnight courier.

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver shall, upon the entry of this Order, provide ADM with all information necessary to effect the wire transfer ordered above.

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that Managed Alternative Investments, LLC ("Managed"), as commodity pool operator for the Fund, shall, no later than 5 business days after entry of this Order, take all steps necessary to effect the transfer of the balance held by ADM for the Fund to the Receiver.

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that no later than 7 days after receipt by the Receiver of the balance held by ADM as ordered above, the Receiver shall notify the SEC that he has received said funds and the amount so received.

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that within 7 days after receiving the notice from the Receiver, as ordered above, the SEC shall file a Notice and Order of Dismissal of Its Claims for Disgorgement and Prejudgment Interest against Relief Defendant Oxford Global Managed Futures Fund, LP.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Court retains jurisdiction over this matter to enforce this Order and all terms contained in the aforementioned settlement agreements.
