No. 41; Civil No. 14-1790 (DWF/FLN), Doc. No. 12; Civil No. 13-2053 (DWF/FLN), Doc. No. 41; and Civil No. 13-2054 (DWF/FLN), Doc. No. 39), and pursuant to a July 2, 2015 telephone conference with the Court regarding the parties' request to reinstate the four above-referenced matters. The letter reflects agreement by the parties, as well as the agreement of all other relevant parties, including the above-Plaintiffs and their attorney, that reinstatement is appropriate at this time.

Accordingly, it is **HEREBY ORDERED** that:

1. The Order for Dismissal Without Prejudice in each of the above-referenced matters is **VACATED** (Civil No. 13-2055 (DWF/FLN), (Doc. No. [37]); Civil No. 14-1790 (DWF/FLN) (Doc. No. [8]); Civil No. 13-2053 (DWF/FLN), (Doc. No. [37]); Civil No. 13-2054 (DWF/FLN), (Doc. No. [35]); MDL No. 13-2441 (DWF/FLN), Doc. Nos. [636], [637], [638], and [639]).

2. Plaintiff's Motion regarding a briefing schedule and common benefit fees is **DISMISSED AS MOOT** (Civil No. 13-2055 (DWF/FLN), (Doc. No. [40]); Civil No. 14-1790 (DWF/FLN), (Doc. No. [11]); Civil No. 13-2053 (DWF/FLN), (Doc. No. [40]); Civil No. 13-2054 (DWF/FLN), (Doc. No. [38]); MDL No. 13-2441 (DWF/FLN), (Doc. No. [649])).

3. All of the above-referenced matters (Civil No. 13-2055 (DWF/FLN), Civil No. 14-1790 (DWF/FLN), Civil No. 13-2053 (DWF/FLN), and Civil No. 13-2054 (DWF/FLN)) are **REINSTATED**.
