**ORDER AUTHORIZING THE RECEIVER TO SEIZE ASSETS AND INSPECT
FORTHWITH THE RESIDENCE
OF GINA AND TREVOR COOK**

On the basis of the Motion of the Receiver, R. J. Zayed, to seize assets of the Receivership and inspect forthwith the residence of Gina and Trevor Cook, the Court having been advised in the premises and having considered the materials before it enters the following:

IT IS HEREBY ORDERED THAT:

Gina Cook’s and Trevor Cook’s objections are hereby overruled. The Receiver is authorized to seize assets in the possession or control of Gina and Trevor Cook, including, but not limited to the watch held in Ms. Cook’s safe deposit box at Wells Fargo bank, a 2005 Lexus 33 series, a 2004 Lexus L43, a 1997 BMW 328ic, all domestic

and foreign currency in the Cooks' custody, possession, and control, Mr. Cook's collections of Faberge eggs and watches, and a ROM exercise machine.

IT IS FURTHER ORDERED THAT:

Gina and Trevor Cook shall immediately provide these assets to the Receiver upon issuance of this Order.

IT IS FURTHER ORDERED THAT:

The Receiver is authorized to enter and fully inspect forthwith the residence of Gina and Trevor Cook at 12735 Dover Drive in Apple Valley, Minnesota, including the inspection of any and all inside and outside areas of the property, safes, secret hideaways or compartments or hollowed structures, whether such areas, hideaways, compartments or structures are open, locked, accessible or inaccessible.

IT IS FURTHER ORDERED THAT:

Gina and Trevor Cook shall allow the Receiver and his agents complete access to any and all areas of the property including any and all inside and outside areas of the property, safes, secret hideaways or compartments or hollowed structures, whether such areas, hideaways, compartments or structures are open, locked, accessible or inaccessible.

IT IS FURTHER ORDERED THAT:

The Receiver is further authorized to use any photographic, video, or other means to record the contents of the property that are uncovered in the search, including forensic imaging of all computers and photocopying of any relevant documents that are found on the premises. Such imaging and photocopying may, at the Receiver's option, be

performed at an off-site location with the originals to be returned to the Cooks upon completion.

IT IS FURTHER ORDERED THAT:

The Receiver shall be authorized to remain on the premises until such time as the inspection is completed.

IT IS FURTHER ORDERED

That Ms. Cook has the option to purchase the 2005 Lexus 33 series from the Receivership for fair value as mutually agreed between Ms. Cook and the Receiver. To that end, Ms. Cook has two weeks from the date of this Order to obtain financing to purchase the vehicle.

IT IS FURTHER ORDERED

That information obtained from the search that relates solely to Ms. Cook's work for Cargill, be treated as Attorneys Eyes Only, such that access will be limited to the Receiver and his agents, and counsel for the SEC, CFTC, and United States Attorney's Office.
