**AMENDED ORDER**

The Receiver, R.J. Zayed (“Receiver”), has filed a Motion for a Rule To Show Cause Against Gina Cook (CFTC Docket Nos. 264-67, 269 and SEC Docket Nos. 261-64, 266) and the Court has issued an Order for Cook to show cause, if any, why Gina Cook should not be held in civil contempt for failing to comply with the Court’s Orders appointing R.J. Zayed as Receiver of the Defendant and Relief Defendant Estates and freezing all assets of the Receiver Estates (CFTC Docket No.: 268 and SEC Docket No. 265). The parties have filed an Amended Stipulation in this matter.

The Court having jurisdiction over the parties and the subject matter hereof, and being fully advised in the premises, now states:

IT IS HEREBY ORDERED that:

1. Gina Cook was served with and provided with actual notice of the Receiver’s Motion for a Rule To Show Cause Against Gina Cook and supporting papers (CFTC Docket Nos. 264-67, 269 and SEC Docket Nos. 261-64, 266) and has waived any right to a hearing thereon.


2. Gina Cook was served and provided with actual notice of the Court’s Receivership and Asset Freeze Orders and has acted in disregard of those Orders by attempting to sell a Receivership asset, the residence located at 12735 Dover Drive, Apple Valley, Minnesota 55124 (the “Dover Drive” residence), without the Receiver’s permission, without leave of the Court, and in contravention of 28 U.S.C. § 2001(b).

3. Funds from Receivership Estates paid for 53 out of 54 mortgage payments on the Dover Drive residence, totaling \$160,452.91.

4. Trevor Cook supplied \$155,901.33 in cash toward the purchase of the Dover Drive residence.
5. The Receivership has an interest of \$316,354.24 in the Dover Drive residence.
6. The sale of the Dover Drive residence shall be directed by the Receiver and governed by the Court, 28 USC § 2001(b), and all other applicable laws.
7. After satisfaction of the outstanding mortgage, all proceeds from the sale of the Dover Drive residence up to \$316,354.24 shall be paid directly to the Receiver. Any remainder shall be paid to Gina Cook.
8. Gina Cook has executed an Occupancy Agreement with the Receiver as part of the Amended Stipulation. That Occupancy Agreement is hereby made part of this Order.
9. Gina Cook shall execute an unsecured bond within twenty-four (24) hours of entry of this Order, binding her to pay the Receiver up to the amount of three-hundred sixteen, three hundred fifty-four dollars and twenty-four cents (\$316,354.24) in the event of any violation of this Court's Orders or this Stipulation.
