**ORDER TO SHOW CAUSE FOR
FAILURE TO COMPLY WITH PRETRIAL ORDER**

WHEREAS, pursuant to Pretrial Order No. 7 (Docket No. 157), Plaintiffs with pending cases were required to serve a completed and executed Plaintiff Fact Sheet no later than July 20, 2016, and in cases subsequently assigned to this Multidistrict (“MDL”) Proceeding required to serve a completed and executed Plaintiff Fact Sheet no later than 60 days after the case becomes part of these MDL proceedings;

WHEREAS, on February 14, 2017, Counsel for the Defendants presented the Plaintiffs’ Steering Committee with a list of the Plaintiffs who have failed to provide a Plaintiff Fact Sheet, and whose deadline to do so has passed; and

WHEREAS, the Plaintiffs in the actions identified on Exhibit 1, who were among the list of Plaintiffs identified for Plaintiffs’ Steering Committee on February 14, 2017,

have still not provided a Plaintiff Fact Sheet, as required by Pretrial Order No. 7, and the deadline to do so has passed;

IT IS HEREBY ORDERED that:

1. On or before April 7, 2017, a copy of this Order shall be sent via email by the Plaintiffs' Steering Committee to Plaintiffs' counsel in the *Abrahams* and *Hicks* actions identified on Exhibit 1;
2. On or before April 7, 2017, a copy of: (a) this Order; and (b) Pretrial Order No. 7, including Exhibit A thereto (a blank copy of the Plaintiff Fact Sheet) shall be sent by the Plaintiffs' Steering Committee to *pro se* Plaintiffs Joni Schleif and Danny Schleif, identified on Exhibit 1, at their last known address of 822 South Birdsey Street, Columbus, WI 53925;
3. On or before April 28, 2017, the Plaintiffs identified on Exhibit 1 shall serve the requisite Plaintiff Fact Sheet pursuant to Pretrial Order No. 7; and
4. For each Plaintiff identified on Exhibit 1 who has not served the requisite Plaintiff Fact Sheet pursuant to Pretrial Order No. 7, or otherwise shown cause sufficient to the Court as to why it cannot be provided, within the time period stated above, counsel for Defendants shall submit a proposed Order of Dismissal to the Court and the Court will dismiss, with prejudice, each said case.
