**ORDER DISMISSING WITHOUT PREJUDICE CERTAIN UNRESPONSIVE,
UNREVISED PLAINTIFF LAWSUITS**

In further management of its docket, on September 12, 2019 the Court entered Pretrial Order No. 42 (“PTO #42”) establishing certain mandatory tolling election response obligations on the part of Unrevised Plaintiffs in this multidistrict litigation. Pursuant to that PTO #42, the response deadline was October 28, 2019. By way of further Order on January 14, 2020, the Court extended the deadline to January 31, 2020 for those Unrevised Plaintiffs who had failed to respond by the original date, and also noted that failure to respond by the extended date would result in dismissal without prejudice and without further notice of the unresponsive, Unrevised Plaintiff matters. Attached hereto as Exhibit A is a list of such unresponsive, Unrevised Plaintiff matters pending before this Court.

IT IS HEREBY ORDERED that:

The pending unresponsive Unrevised Plaintiff matters identified in Exhibit A hereto are hereby dismissed in their entirety without prejudice and without costs to any party.
