**IN RE:** ENTRANCE PROTOCOL IN RESPONSE TO COVID-19

## **ADMINISTRATIVE ORDER**

The U.S. Marshals, Court Security Officers (CSOs), and Protective Security Officers (PSOs) must restrict the following from entering a U.S. Courthouse in the District of Minnesota:

- 1. Anyone who has traveled to any country, state, or area identified on Attachment A to this order within the last 14 days;
- Anyone who resides or has had close contact with someone who has traveled to any country, state, or area identified on Attachment A to this order;
- 3. Anyone who has been asked to self-quarantine by any hospital or health agency; or
- 4. Anyone who has been diagnosed with or has had contact with anyone who has been diagnosed with COVID-19.

Any visitor who meets the restricted categories above must inform the CSOs upon entering the courthouse.

Any attorney who meets the restricted categories above and who is scheduled to appear before the Court in the near future must notify the presiding judge of the case so that appropriate safeguards can be taken. Attorneys may appear via teleconference or videoconference, with the approval of the presiding judge.
