NOTICE TO ALL MEMBERS OF THE BAR OF THE DISTRICT OF MINNESOTA WITH LAST NAMES BEGINNING WITH LETTERS A-G REQUIRED ATTORNEY RE-REGISTRATION

The U.S. District Court for the District of Minnesota requires members of its Bar to re-register every three years in order to maintain an accurate roll of admitted attorneys. Attorneys with last names beginning with the letters **A-G** <u>ONLY</u> must re-register at this time and pay the required \$40.00 fee. Attorneys for the U.S. Government must also re-register but are exempt from paying the required re-registration fee. Attorneys who fail to re-register by <u>April 1, 2020</u> will be considered "inactive," their ECF accounts will be suspended, and they will be unable to obtain certificates of good standing. <u>Recently admitted attorneys to the Bar of this Court in 2018, 2019, or 2020 do not need to re-register at this time.</u>

IF YOUR LAST NAME BEGINS WITH THE LETTERS A-G, PLEASE FOLLOW THE INSTRUCTIONS BELOW

- 1) Log into your **ECF Account** at https://ecf.mnd.uscourts.gov. You will need your PACER Username and Password.
- Once logged in, click on the UTILITIES tab then click MAINTAIN YOUR ACCOUNT.
- 3) Update or verify that your information is accurate.
- 4) Click on the **UTILITIES** tab again and click **ATTORNEY RE-REGISTRATION**.
- 5) ECF will guide you through the re-registration process, including paying your required re-registration fee through Pay.gov. You will need a credit card.
