MDL CASE REPORT

A new MDL Case Report is now available on the District of Minnesota's Case Management/Electronic Case Filing (CM/ECF) system.

The MDL Case Report lists all cases associated with a Judicial Panel on Multidistrict Litigation (JMPL) action pending in the District of Minnesota. The report is sorted by case number and case type (the main MD case is always listed first). The user can choose whether all MDL-related cases or only pending MDL-related cases should display.

This report is accessed through Public Access to Court Electronic Records (PACER), which is an electronic public access service that allows users to obtain case and docket information. Access to court documents through PACER costs \$0.10 per page.

You will need to have a PACER login and password to access this report. To register for a PACER account, go to PACER's site at: https://pacer.uscourts.gov/register-account/pacer-case-search-only

Follow the steps below to access the MDL Case Report through PACER:

- 1. Access the District of Minnesota's CM/ECF system at: https://ecf.mnd.uscourts.gov
- 2. Log into the system with a PACER login and password.
- 3. Click on **Query** on the blue menu bar.
- 4. Enter in a master MDL case number or an associated case number for a JPML case pending in the District of Minnesota.
- 5. Click **Run Query**.
- 6. Click the link, MDL Case Report.
- 7. Select the applicable radio button to display all cases or pending cases only then click **RunQuery**.
- 8. The output will then display accordingly.
